IN GENERAL: This application must be filed with the Tax Assessor within 185 days from the date of commitment of the tax to which objection is made.

Application must be signed and include eight (8) complete applications and attachments.

**Question 1:** Print full name.

**Question 2:** Print Tax Map/Lot # and Property Location.

**Question 3:** Print Personal Property "Business" Account Number #.

**Question 4:** Print full address to which mail should be sent.

**Question 5:** Print Phone number and e-mail address if applicable.

**Question 6:** Taxes are assessed as of April 1. The tax assessed as of April 1 of any year and billed thereafter is for the tax for that year.

**Question 7:** Show the actual assessed valuation of the particular parcel of Real Estate covered by this application, as to which abatement is requested. If abatement of Real Estate valuation is not requested, do not fill in this item.

**Question 8:** Show the amount by which you believe the Real Estate valuation should be reduced. For example if Real Estate valuation (shown in Question 7) is \$300,000 and you believe it should be \$250,000, the entry would be \$50,000.

**Question 9:** Show the actual assessed valuation of Personal Property, Business Equipment. If abatement of Personal Property is not applicable, leave blank.

**Question 10:** Show the amount by which you believe the Personal Property, Business Equipment, valuation should be reduced. For example if valuation (shown in Question 9) is \$10,000 and you believe it should be \$7,000, the entry would be \$3,000.

**Question 11:** State the reasons why you believe you are being overvalued. Please be specific.
